

## RULES AND CONDITIONS FOR VISITORS AT PORT DE PLAISANCE LA RONDE 2022

**TO ENSURE THE COMFORT AND SAFETY OF BOATING AND STAFF EMPLOYEES OF PORT DE PLAISANCE LA RONDE HAVE THE DUTY TO COMPLY AND ENFORCE THE FOLLOWING:**

1. A BOAT GOES UNDER THE JURISDICTION OF ITS EXPOITANTS ENTERING THE MARINA.
2. ON ARRIVAL, THE BOATER MUST SUBMIT TO THE POST OF CONTROL AND REGISTER TO RECEIVE THE DOCUMENTATION AND TAKE A CARD MAGNETIC RECORDING TO COST \$ 20. ORIGINALLY THE CARD MUST BE RETURNED TO THE RECEPTION FOR CREDIT OF \$ 20. IF THE CARD IS NOT RETURNED IN THE NEXT 7 DAYS, IT WILL BE OFF AND REFUNDS WILL NOT BE POSSIBLE. DO NOT PUT THE MAGNETIC CARD NEAR ELECTRONIC DEVICES. YOU ARE RESPONSIBLE FOR THE STATE OF CARD.
3. THE PRICE OF A RENTAL DOCK IS CALCULATED ON THE OVERALL LENGTH OF THE BOAT. IT MAY NOT STATED IF THE LENGTH NOT CORRESPOND TO THE ACTUAL LENGTH OF VESSEL, THE MARINA VALID DIMENSION AND READJUSTED THE PRICE OF CURRENT LOCATION.
4. AN ELECTRICAL OUTLET 30 AMP POWER AND WATER ARE INCLUDED. PLEASE HAVE YOUR POWER ADAPTER AN Y OR HAVING AN ELECTRIC ADAPTEUR 30/15 AMP OR 15 / 30AMP FOR SMALLER BOATS.
5. RESERVATION FOR SHORT STAY, FULL PAYMENT IS REQUIRED AT REGISTRATION. CANCELLATIONS MUST BE 24 HOURS BEFORE BOOKING (BEFORE 11H00AM) BY PHONE WITH CONFIRMATION OF CREW, CREDIT OF 75% WILL BE REFUNDED AND CONFIRMATION WILL BE SENT BY E-MAIL. THERE IS NO REFUND OR TRANSFER FOR BOOKING ON DAYS OF FIREWORKS
6. NO RESERVATION IS TRANSFERABLE TO ANOTHER BOATER. IF THE BOATER CHANGE HIS BOAT BEFORE THE BOOKING DAY, IT MUST NOTIFY THE PERSONNEL, AND PAY AGAIN THE CONTRACT IF THE DIFFERENCE HAVE CHANGED THE DIMENSIONS. IT IS POSSIBLE THAT BOAT CAN CHANGE THE LOCATION IF THE LATTER DOES NOT CORRESPOND MORE LOCATION DEPARTURE REGISTERED. NO SUBLETTING IS TOLERATED.
7. FOR LARGE BOATS THAT HAVE A SMALL BOAT SIDE (DINGHY), YOU MUST HAVE A SUPPORT FOR HANG ON YOUR BOAT FOR SPACE. DO NOT BLOCK THE BOAT ENTOUR. FEES ARE ADJUSTED ACCORDING TO SPACE THAT TAKES DINGHY ON THE BOAT.
8. THE MARINA PARKING LOCATED NEAR THE RAMP IS ONLY FOR MEMBERS, THERE IS A DEDICATED PARKING FOR THE VISIT. ANY VISIT HAS TO PAY THE PARKING THE LA RONDE TO HAVE ACCESS TO OUR PARKING.
9. THE MARINA PROVIDES THE DOCK CARTS FOR BOATING, PLEASE RETURN THE DOCK CART TO ITS SPACES, **DO NOT LEAVE THE ON THE DOCKS ..**
10. THE SPEED LIMIT IN THE BASIN IS 5 MPH, THE WAKE AND WAVES ARE STRICTLY FORBIDDEN. ALL BOATS MUST MOOR OF BACKWARD WHARF EXCEPT FOR SAILING BOAT AND PONTOONS. IT IS TO HAVE AT LEAST 3 ROPES TO ATTACH THE BOAT AT DOCK, TWO ON THE SIDE AND ONE TO ATTACH THE BACK OF THE BOAT ON THE MAIN DOCK.
11. DO NOT INSTALL PROTECTION ON THE DOCKS. WHICH REQUIRES NO INSTALLATION SCREWS OR NAILS OR ANY OTHER HARDWARE ON THE DOCKS. ONLY THE FENDERS WITH LINES ATTACHED TO THE BOAT ARE ACCEPTED.
12. **IMPORTANT SAFETY AND FOR ALL!** EVERY TIME THAT LEFT THE BOATING DOCK FOR NAVIGATION MUST REMOVE HIS ELECTRIC WIRE TERMINAL TO DOCK TO AVOID THE WIRE FALLS IN WATER **WITH POWER!**
13. NOW, THERE IS NEAR THE RAIL CONTAINER WHERE THE CUSTOMER MUST FILE ITS GARBAGE BAG. SMALL BINS INSTALLED NEAR GAZEBO WILL BE USED ONLY FOR INDIVIDUAL WASTE. DO NOT PLACE YOUR GARBAGE BAGS AND ALCOHOL BOTTLES IN SMALL GARBAGES.
14. IN PARKING LOT, THERE IS AN AREA PLANNED FOR MOTORCYCLES AND BICYCLES.
15. FOR SAFETY, ACCESS AND DOCKS SPACE SHALL BE FREE AT ALL TIMES. ANY TABLE, B.B.Q. PURPOSE OR OTHERWISE ARE TOLERATED ON THE DOCKS. THE CHAIRS ARE BEINGS PERMITTED DURING THE NIGHT FIREWORKS BUT **SHOULD NOT BLOCK TRAFFIC**
16. IT IS FORBIDDEN TO USE SPACE DOCK COMMERCIAL PURPOSES AT ALL TIMES.
17. IN 2021, THERE WILL BE A NEW HABOR MASTER'S OFFICE INCLUDING A LITTLE BISTRO COFFEE AND A TERRACE. ALL BOATERS WHO WILL COME TO THE HABOR MASTER'S OFFICE MUST HAVE DRESS CODE (NO SWIMSUIT). THE BISTRO AREA AND TERRACE WILL BE RESERVED FOR CUSTOMERS WHO WILL CONSUME THE BISTRO'S EXCLUSIVE PRODUCTS. NO CONSUMPTION FROM OUTSIDE WILL BE TOLERATED. THE EXTERIOR SPACE OF THE TERRACE WILL BE NON-SMOKING AND NO CUSTOMERS CAN USE THE TERRACE WHEN THE CAPITAINERIE IS CLOSED.
18. IT IS FORBIDDEN TO TAKE ANY DRUGS IN ALL PUBLIC AREAS OF THE MARINA. WE TOLERATE AGAIN CIGARETTE BUT PLEASE HAVE YOUR ASHTRAY, NO CIGARETTE ON THE FLOOR OF THE MARINA AND ESPECIALLY NOT THROW CIGARETTE IN WATER, THINK ABOUT THE ENVIRONMENT. NO OIL SPILL, ALCOHOL, FLAMMABLE LIQUIDS IN THE BASIN OF THE MARINA.
19. THE B.B.Q. MAY BE USED ON THE BOAT AND THE PICNIC AREAS.
20. IT IS FORBIDDEN TO RUN ON THE DOCKS. NO MEANS OF TRANSPORT IS TOLERATED ON THE DOCKS.
21. THE PDF VEST IS STRONGLY RECOMMENDED FOR YOUNG CHILDREN ON THE DOCKS.
22. MECHANICAL REPAIRS ARE PROHIBITED ON THE DOCKS.
23. ALL BOATS MUST BE IN GOOD ORDER WITH GOOD MECHANICAL. IF YOU HAVE ANY BREACH OF MECHANICAL, PLUMBING, ELECTRICITY, OR OTHER SURE Y REMEDY FAST. WE DO NOT TOLERATE NEGLIGENCE. SHIP MAY BE EXPELLED WITHOUT COMPENSATION IF THE TENANT ASSUMES NO IMMEDIATE REPAIR.
24. THE LAUNCHING AND DRY STACK, AS WELL AS ANY OPERATIONS AND HANDLING OF VESSELS THAT WILL NOT BE UNDER THE SOLE RESPONSIBILITY OF THE OWNER OF THE BOAT.
25. **IT IS FORBIDDEN TO BRIG AND MAKE FUEL TANKS ON THE DOCKS AT ALL TIMES. THERE IS A GAZ STATION.**
26. ENSURE THAT ANY TIME WORK BILGE PUMPS AND CHECK THE STATUS OF HIS BOAT IN HEAVY RAIN. FEE WILL BE CHARGED IF THE MARINA IS EMPTO BOAT FILLED WITH WATER.
27. **CURFEW IS 9:00PM. NO EXCESSIVE NOISE OR BE TOLERATED LOUD MUSIC AT ALL TIMES. MUSIC IN THE BOAT IS FOR YOURSELF AND NOT FOR THE NEIGHBOURS. RESPECT FOR OTHERS IS. ANY INDIVIDUAL OR GROUP TO UNACCEPTABLE BEHAVIOUR BE EXPELLED WITHOUT NOTICE OR COMPENSATION OR REFUND.**
28. ANIMALS ARE ACCEPTED BUT MUST BE ON **A LEASH** AT ALL TIMES. CLEANLINES OF PREMISES IS VERY IMPORTANT, PLEASE PICK UP YOUR DOG NEEDS. NO ANIMAL IN THE BOAT LEFT UNATTENDED. THEIR ATTENDANCE WILL BE PROHIBITED IF THEY BOTHER USERS' MARINA.
29. IT IS FORBIDDEN TO FISH OR SWIM IN THE BASIN PORT DE PLAISANCE LA RONDE. ACCIDENTS IS AT YOUR OWN RISK. THERE IS A LOT OF ELECTRICAL CURRENT NEAR DOCKS!!!
30. DO NOT FEED THE WILD ANIMALS AND BIRDS IN THE BASIN. BIRDS MAKE A LOT OF DAMAGE TO THE CANVAS, HULL AND PLATFORMS OF BOATS ...
31. THREE POLICE: ROYAL CANADIAN MOUNTED POLICE, SAFETY OF QUEBEC, MUNICIPAL POLICE HAVE JURISDICTION ON THE APPLICATION OF LAWS AND REGULATIONS APPLICABLE TO NAVIGATION.
32. IN CASE OF VIOLATION OF THE ABOVE REGULATION, DISORDERS, IMPAIRMENT OF GOODWILL OR CONDUCT OF COMMITTED BY A BOAT OWNER, CREW OR HIS GUESTS, WHICH COULD RESULT IN INJURY TO PERSONS AND PROPERTY DAMAGE OR UNDERMINE THE REPUTATION MARINA, THE BOAT IN QUESTION WILL BE SENT ON FIELD WITHOUT COMPENSATION AND REIMBURSEMENT.
33. THE TENANT AGREES TO PAY THE COST OF ANY DAMAGE TO PROPERTY LANDLORD, OR ANY OTHER PROPERTY TENANT LANDLORD RESULTING DIRECTLY OR INDIRECTLY FROM THE FAULT OF THE TENANT.
34. THE PORT DE PLAISANCE LA RONDE ASSUMES NO RESPONSIBILITY FOR THE CUSTODY AND CONTROL OF SHIPS AND FOR INJURY CAUSED TO THE SITE. THEFT, FIRE, ACCIDENT OR DAMAGE TO THE BOAT DOCK AND ANCHORAGE ARE THE RESPONSIBILITY OF THE CLIENT.
